

1984

June 5, Inuvialuit Final Agreement signed

1995

Federal Inherent Right Policy

1996

Gwich'in and Inuvialuit self-government negotiations begin

2003

April 16, Gwich'in and Inuvialuit Self-Government Agreement-in-Principle signed

2006

Inuvialuit begin negotiating an Inuvialuit Self-Government Agreement

2007

May 4, Inuvialuit Process and Schedule Agreement signed

2008

Agreement-in-Principle negotiations currently in process

2009

Agreement-in-Principle to be completed

2011

Final Agreement to be completed

Implementation of the Self-Government Agreement will begin following the approval of the Final Agreement. Approval is required by Inuvialuit beneficiaries, the NWT Legislative Assembly, and the Parliament of Canada. Following the approval process, the implementation plan will ensure that the actions set out in the Final Agreement are properly carried out.

TOWARDS AN AGREEMENT-IN-PRINCIPLE (AIP)

The Parties are in the process of negotiating an Agreement-in-Principle (AIP). The negotiating parties will focus their discussions on the AIP details of the specific jurisdictions and powers. The Process and Schedule Agreement, signed on May 4, 2007, outlines relevant topics to be discussed during the current AIP negotiations.
