- Implement the strategic priorities outlined in Building on Our Foundation 2011-2016: A Strategic Plan for NWT Health and Social Services System, with particular emphasis on the following:
 - Reform governance of the health and social services system and improve measurement and accountability within the system,
 - Continue to improve the availability and effectiveness of mental health and addictions treatment services in the Northwest Territories,
 - Building on the existing service delivery model, continue to enhance access to services through use of technology and expanded scopes of practice, including expansion of midwifery services,
 - Develop a Pharmaceutical Strategy for the NWT, resulting in more cost-effective acquisition of drugs,
 - Work with communities to support initiatives that promote increased understanding of the role of prevention in health and wellness, including completion of a cancer strategy.
- Continue to advance the potential for increased efficiencies through implementation of shared and collaborative services within the health and social services system, with a focus on IS/IT and finance/procurement.
- Work with other Social Envelope Ministers to implement and monitor the NWT Anti-Poverty strategy and GNWT Action Plan.
- Continue to promote improvements in Aboriginal health by building on community wellness plans, supporting communities to implement prevention and promotion initiatives, and promoting on-the-land healing and cultural competency.
- Together with the Minister of Education, Culture and Employment, implement and monitor the comprehensive Early Childhood Development Framework.
- Support the efforts of our government to transition to post-devolution roles, including new decision-making authorities and responsibilities for land, water and resource management.
- Support the efforts of our government to advance the federal engagement strategy.
